

Review Meeting

A Children In Care (CIC) review meeting is being held on
for your child or children and chaired by
(IRO).
It is important that your child's care plan records their individual care needs and how these needs will be met.
To make sure this is up to date they need to be reviewed regularly. This is done as part of the Children in Care (CIC) Review. The review normally takes between one and two hours to complete.
This form gives you a chance to tell us what you would like talked about at the meeting. Don't worry about spellings or neat handwriting and please ask your child's social worker if you need help filling out the form. Please let us know if you feel comfortable to attend the review and if there is any support you need?

Have we been able to help you keep in touch with your child (we call this Family Time)? Are there any changes you would like made to these arrangements? Is there anyone who is important to your child who has no current contact with them?

What is an IRO?

Your child's review will be chaired by an Independent Reviewing Officer (IRO) and it will usually be the same IRO who chairs all of the CIC reviews for them. The IRO is independent of the social work team and is responsible for reviewing/monitoring your child's care.

The name of the IRO is written at the start of this form and you can speak to them before the review by calling

Your legal rights

Do you know that under the Children Act 1989, you have the right to apply for a court order to formalise arrangements for seeing your child. You can apply to discharge a care order.
